### Provisional Admission Circular for Class XI Session 2026-27

Applications are invited for Provisional Admission to Class XI Science and Commerce Streams for the Session 2026-2027.

#### General Information:

- Eligibility Criteria:** Students who have appeared in Class X Pre-Board Exam in the session 2025-26 with 75% and above marks (for Science), 70% and above marks (for Commerce) in the Pre-Board exams of the school.
- At present provisional admission will be granted. It will be confirmed after the declaration of the result of Board Exam and fulfillment of minimum marks criteria.
- Minimum **75% Marks for Science Stream** (English, Maths & Science Only) and **70% Marks for Commerce Stream** (English, Maths & Social Science Only) in the Board exam, is required for admission. A relaxation of **5% in Marks** will be considered for sports quota (State or National Level Only).

**Direct Provisional Admission will be given to Students Securing 90% & Above Marks in Pre-Board or Board Exams.**

- Subjects Offered:** English, Physics, Chemistry, Mathematics, Biology, Artificial Intelligence (AI), Information Technology (IT), Fine Arts, Accountancy, Business Studies, Economics, Applied Maths, and Entrepreneurship.
- Only shortlisted candidates will be considered for provisional admission through offline entrance test.
- Copy of Pre-Board Marksheet is required for filling up of the form.
- Last date for applying is 31-03-2026 latest by 5:00 P.M.

#### Payments Details:

- First payment of Rs. 750/- for registration for appearing in **Offline Entrance Test** to be held on 03-04-2026 at 9:30 am.
- Second payment of Rs. 10,700/- as **Provisional Admission fee (non-refundable)**. This amount will be adjusted, if admission is confirmed, post declaration of CBSE X board result. **This amount will not be refunded in case of withdrawal or non-confirmation of admission.**
- Bus facility will be provided after the payment of full month fee for April & May 2026 on the basis of transport route.
